# 3. Who Won?

It is tempting to state that everyone in the club house or on the course was a winner as the recession was forgotten and the splendid welcome and hospitality of the club was thoroughly enjoyed. But, just as in this month's Rugby World Cup, there were some worthy winners and some unfortunate losers. That pesky little white ball did not always travel where the course designers had intended; the club house itself proving to be too tempting a target for one enthusiastic golfer on the very first tee. The

Chamber of Commerce Challenge Cup was won by Dover for the first time in seven years, aided by a strong team from DFDS Seaways and some wise management by team captain Ted Lamb of Country Carpets. The Corporate Team Championship saw a close encounter with the Walpole Bay Hotel claiming third place, just behind Country Carpets; but, they both had to acknowledge the eventual winners DFDS Seaways A. The Individual Championship was keenly contested. Russell McKelvey won the trophy but was made to battle hard to draw away from Durham Lamb, Jeff Darraway, Jonathan Smith and Alastair Narraway. Durham Lamb may have needed a golf buggy all on his own to carry away a rich prize haul of trophies, champagne, golf balls, certificates and golf equipment as he came second in the Nearest The Pin Challenge and won the Longest Drive Competition and the prestigious Ray Haines Memorial Trophy, named after the late Chief Executive of Dover District Chamber of Commerce who will be remembered by many among the area's golfing fraternity. Jonathan Page and Bradley Ellison were just pipped in the Longest Drive. Justin Bishop showed his class as an ex-professional by getting his ball nearer to the pin than anyone else. Tony Marsh, who came third, must be an each way bet for next year.

Despite difficult trading conditions during the past twelve months, the Chamber Golf Tournament brought together some of East Kent's most successful companies, proving that confidence in the local economy is growing. #### 6. News From Canterbury Christ Church University

On 5th October 2011, Canterbury Christ Church University launched the England Centre for Practice Development. Under the direction of Professor Jan Dewing, Professor Kim Manley and Carolyn Jackson, this pioneering department will focus research on implementing best practice and improving patient care. The intention is to find what works best from anywhere in the world and to ensure that this informs the decision-makers in our hospitals, surgeries and medical centres. The emphasis is on procedures and practices that make a genuine difference to our lives. Present at the launch was the boss, the University Pro-Chancellor Peter Hermitage. He started his career as a humble constable and became a Chief Constable. Later, at the Home Office he had special responsibility for personnel issues and value for money. Later still, he headed the East Kent NHS Hospital Trust and served as Chairman of the Security Industry Association. This is a man who knows how to manage people and how to add value. As a football manager might say: "The boy done good". We just hope that a team in Greece or Italy does not seek his transfer because he is one of Thanet's own, an alumnus of Chatham House School, whose management expertise is required on his home patch.

#### 7. Investment Fund

The Thanet & East Kent Chamber is close to reaching an agreement on establishing an investment fund to which members can apply for development capital to boost their business. #### 8. Margate Shooter

# 10. How Are We Doing?

We are grateful to the Research & Information department of Kent County Council for supplying the latest unemployment data for Kent. Although the monthly fluctuations are of passing interest, as always it is the year-on-year changes that tell us more about job market trends. There is no disguising the fact that the figures for September 2011 do not not compare favourably with the data from September 2010. The Kent district with the biggest increase in unemployment benefit claimants is Dover which shows a massive 25.2% rise in registered unemployed. Within the district, Walmer is particularly affacted with a 46% increase in claimants. Anyone who has followed the news about the closure of Pfizer will not be surpirsed that Sandwich itself now has reduced its workforce by over 30% compared to twelve months previously. No district in Kent has escaped the decline, but Dartford 8.1%, Sevenoaks 7.3% and Tunbridge Wells 2.4% have at least outperformed the rate of decline in Great Britain which stands at 9.9%. Along with the interest rate, exchange rate and inflation rate, unemployment is one of the key economic indicators that measure our economy and inform us of our economic health. Here are the results for East Kent. The right hand column indicates the annual change in the number of registered unemployed.

# II. Jobs Fair

# 12. Kent Social Services

We understand that last week Kent County Council's Children's Social Services received an unannounced visit from OfSTED. The inspectors visited four districts as well as the county duty team on Tuesday and Wednesday. From what we have learned at the Chamber, the inspectors recorded "significant improvements since the last inspection some 12 months ago" and crucially the inspection did not specify any 'priorities for action'. This represents considerable progress and something of a triumph for

Jenny Whittle, Ann Allen and their team at County Hall. We look forward to reading the new OfSTED report when it is published.

#### 13. Thanet Surcharge

The difference in prices between a litre of unleaded petrol in Thanet and in Canterbury has widened to record levels. Tesco Broadstairs Extra is charging 134.9p for what can be bought at ASDA Canterbury for 129.7p and at Wincheap Service Station and Morrisons Canterbury for 129.9p. The 5p per litre penalty for Thanet residents and businesses amounts to over £3.00 per tank for the average car, adding costs to every household budget and every trading company in Thanet. It also amounts to a disincentive to shoppers, tourists and visitors who wish to travel in their own vehicle. We shall again be writing to the petrol companies seeking an explanation. This is something up with which we will not put.

# 14. Do Something About It

Are you one of those who just sit backs and complains? Or are you one of those who seeks to do something about it? Our good friends at Locate In Kent have joined forces with the Thanet & East Kent Chamber to assemble a body of evidence to promote better conditions for companies trading in Thanet. If you have a few moments free, please complete the survey to be found at <u>https://www.surveymonkey.com/s/GQMYC7M</u> If you feel that the planning committee of Thanet District Council is acting against the best interests of job creating enterprises, as in the recent notorious decision to block a new state-of-the-art Golf Academy at Manston, this is an opportunity to state your case. Similarly, if the development of Manston Airport with the creation of a possible 3,000 jobs is close to your heart, then feel free to express your views. On the other hand, if you consider any post war development as being horribly modern, you are perfectly entitled to state your views clearly, presumably on a computer you have borrowed from someone else.

#### 15. Remove the Blockages

News has reached the Chamber of blockages at our ports. Specifically, it seems that some of our exporters are finding their goods being delayed at Tilbury Docks and Manchester Airport due to excessively bureaucratic procedures with the result that foreign buyers are being deterred from buying from our manufacturers. In one recent case, a Bedford truck converted into a fuel tanker was delayed at Tilbury for seven weeks before the authorities relented. A consignment of British-made fuel pumps and filters was delayed for over a month at Manchester Airport. It took longer to release the goods than it would have taken to deliver them by sea to their destination in East Africa. All these delays add storage costs and disaffect customers. The Logistics Performance Index published by the World Bank benchmarks countries for their efficiency at transporting goods. The United Kingdom ay have scored a respectable 8<sup>th</sup> place overall in the 2010 data out of a total of 155 countries. There is no sense of triumph in outperforming Somalia which is bottom of the list, but there would be in beating our competitors in Europe. Sadly, the UK lags behind Germany, Sweden, Netherlands, Luxembourg, Belgium, Norway and Finland, not to mention Japan and Singapore for "Efficiency of the clearance process (i.e. speed, simplicity and predictability of formalities) by border control agencies, including Customs". If we are to maximise output from our factories for export, the delays at our ports and airports will have to be reduced.

# 16. Welfare Reform & Business

Chamber Co-President Laura Sandys MP will be one of the speakers at the Thanet Voluntary & Community Sector Forum (TVCSF) event entitled Raising Awareness and Expectations scheduled for Friday 28<sup>th</sup> October at St Georges C of E Foundation School in Broadstairs. With an aim to "bridge the gap between potential employers and employees", the sessions will also illustrate how companies can benefit from disabled people in their workforce and from the support available to enlightened bosses looking to increase their profits. TVSCF is a respected member of this Chamber with a fine record for community support. # **I7. Energy Costs**

Martyn Young of Atlantic Business Resources, tel: 0781 353 7456 and 08456 185088, has once more sent the Chamber an update on commercial energy costs. Martyn notes some reductions in utility charges since last month but recognises the "still huge year-on-year increases". He considers that the rising trend in energy prices may continue for some time in the future. As he puts it: "Longer term the energy companies seem to be expected to fund a large part of the £200bn needed to renew the UK energy infrastructure, which is likely to drive prices up." Martyn is convinced that there is a pressing need to reform the energy markets in order to: "outlaw the 'rollover' B2B contracts as I see no good reason for the privileged position the energy supply companies occupy in being able to write and enforce their own supply contracts without reference to the customer. " Well put,

sir. Local companies have seen massive rises in their energy costs in the last four years which has severely reduced margins for those with heavy usage requirements.

#### 18. Venerable Elvis Speaks

Regular readers of the Thanet & East Kent Insider will be familiar with Thanet's own hermit, the remarkable Venerable Elvis. It is rumoured that he spoke to Major Henry Percy when this distinguished staff officer landed in Broadstairs with the first news of Wellington's victory at Waterloo.
