4. Outrage At Hartsdown

Hartsdown Technology College in Margate is widely regarded as one of Kent's outstanding successes in secondary education. Listed in the top most improved schools in the UK, the curriculum and improving exam results have produced widespread praise from every level of government. There was a justifiable expectation last week that Hartsdown would be included in the list of schools earmarked to receive a share of this government's £2 billion Priority School Building Programme which replaced the previous government's Building Schools for the Future scheme. There were 587 applications for funding in total, resulting in 261 awards of which 14 were in Kent. In an email from Hartsdown to the Thanet & East Kent Chamber, we learned of the acute disappointment felt by the staff and students at the school that Hartsdown had been ignored. "Utter madness" was one comment from a senior member of staff. Head Andy Somers is not one to give up easily and has already enlisted the support of his local MPs and the Kent County Council cabinet member for education in pressing the case for a review. As Andy puts it: "A whole generation of Margate children have gone through their education with the promise of a new school. They are incredibly resilient and they passionately believe that their town is important. As Margate continues to grow and improve a need for new school on our site becomes greater and greater. This is why we will continue to explore every option available to achieve our goal." Six inspectors descended on Hartsdown Technology School in July 2011, not the easiest month for any formal inspection. The subsequent Ofsted report stated: "Care, guidance and support, as well as engagement with the community, are outstanding. Under the inspirational leadership of the Principal and senior staff, as well as the increasingly competent and confident middle managers, the college has continued to secure improvements in external examinations." The Chamber has often commented that as a nation our public funds should reward success and not subsidize failure. Hartsdown is one of the undoubted successes of Margate. Any school that receives an independent assessment that states: "The promotion of community cohesion is outstanding" fully deserves for that support to be returned by the surrounding community. We will be working with Andy and his team to ensure that his case receives the strongest possible backing.

5. Latest On Turner Contemporary

Tracy Emin's first solo show in Margate may not be the perfect complement to the Olympic Torch procession on 19th July 2012, but it will put another spotlight on the Turner Contemporary following the huge numbers that were attracted by the Turner and the Elements exhibition which closed on 13th May 2012. Entitled "She Lay Down Deep Beneath the Sea", the new show opens today and is billed as "themes of love, sex and eroticism are the main focus of this exhibition, which includes embroidery, drawing, mono-prints, painting, neon, tapestry and sculpture." Rodin's The Kiss will remain on display until 2nd September 2012.

6. Waste Consultation

We are grateful to Lillian Harrison, Minerals and Waste Planning Policy Manager at Kent County Council, for asking for asking for the Chamber's views on preferred sites for Waste Disposal as part of KCC's preparations for a new Minerals and Waste Local Plan. The final framework will be in three parts: a Minerals and Waste Plan, a Mineral Sites Plan and a Waste Sites Plan. Following the previous round of consultations, there are now 25 preferred option sites for mineral supply and 21 preferred option sites for waste management. 7. Comments On Unemployment

A slight improvement in the monthly unemployment figures for the UK brings scant comfort to companies trading in East Kent. Uncertainty over the future of the Port of Dover may be one of the factors behind the sharp increase in year-on-year joblessness in the Dover district where employment has declined by 25% since April 2011, the sharpest annual fall of any Kent district. Cliftonville West remains the most deprived ward in Kent with 20.3% of the workforce registered as unemployed which translates to 1,028 adult men and women claiming benefit payments, an increase of 35.8% since last year. Youth unemployment in Thanet remains at an unacceptably high 13.6% which contrasts sharply

with Canterbury where just 3.2% of 18-24 year olds are classified as registered unemployed. We are again grateful to the ever-excellent research & Evaluation Department at Kent County Council for forwarding the latest figures from NOMIS, the source of official labour market data from the Office for National Statistics. 10. Now, About That Meeting

Following his well-received Time Management article in the previous edition of the Thanet & East Kent Insider, chamber member Philip Tilston of Polylink Solutions, tel: 07875 924191, has submitted the second in his series of management advice texts on the subject of Effective Meetings. Fans of Star Trek and Peter Drucker will have plenty to ponder. "Capt James T. Kirk of the USS Enterprise summed up the experience of many when he said: 'A meeting is an event where minutes are taken and hours wasted'. We all know that lots of time is wasted in meetings. If you want real incentive to make meetings more effective, then add up the cost of one hour of everyone attending the meeting. The amount can be frightening. A few simple steps can have a huge impact on the effectiveness of your meetings. Ensure you know what the purpose of the meeting is. This will determine the people you need to be there and provide an idea on how long the meeting needs to run. Set an agenda ensuring that when this is distributed attendees are aware of any pre-meeting preparation required. Stick to timings on agenda items. Ensure all comments are relevant to the topic and there is no drift into social or tangential chit-chat. Be aware of the character of the attendees. Some will want to dominate the conversation and some may not want to say anything. Ensure that attendees can be heard when they have something important to contribute and ensure that the quiet ones have the opportunity to contribute. One person should have the responsibility for taking minutes and making a list of action points with deadlines. Minutes should be written up and distributed as close as possible to the end of the meeting. For the person writing the minutes, everything is clearer. It is quicker to write them while the details are fresh rather than waiting and trawling through hastily written details. Also, some attendees will not start work on their action points until they have the minutes and action points. Some will use this delay to justify missing agreed deadlines. Set a culture where people know that they have to be at meetings on time. That includes you. People will look to you for what behaviours are important in the organisation. Most importantly, if you can avoid having a meeting then don't. As the late business guru Peter Ferdinand Drucker put it: 'Meetings are a symptom of bad organisation. The fewer meetings the better".

11. More On Manston

Thanet District Council has now produced its official response to the night flights proposals put forward by the owner of the Airport last October, see http://www.thanet.gov.uk/news/latest_press_releases/night-time_flying.aspx. The Chamber is consulting with its members and board of directors to frame a response of its own to the conclusions of the council. We note that one of the reasons put forward by Thanet District Council to oppose two night flights at Manston Airport in the period 2300 hrs to 0700 hrs invokes The Human Rights Act. This legislation was introduced by the British Government in a wave of idealism in 1998. It has its origins in the European Convention on Human Rights which was drafted by Sir David Maxwell Fyffe in 1952 in the aftermath of the Second World War. Maxwell Fyffe had been a prosecutor at the Nuremberg trials. When drafting the convention, it seems unlikely that this distinguished lawyer, Solicitor-General, Home Secretary and Lord Chancellor had in mind a measure to block the creation of jobs at an airport that has been in operation since 1915. In the cold war Manston proudly welcomed round the clock flights of USAF Thunder Jets.

12. Job Vacancy

We have been approached by Age UK with details of a post available for a Chief Officer at the Margate office. The successful candidate will benefit from a permanent contract, an annual salary of between £36,000 and £38,000 and a working week of 37.5 hours. The main task of the Chief Officer will be to coordinate the activities of the Thanet office to meet the needs of older people and their carers. However, the following account is for interest only and we cannot under any circumstances recommend any imitative behaviour. We have our doubts about the story but we leave it to the good sense of our readers to judge for themselves. As our Chamber member put it: "I saw the news about New Romney being a possible dump for Nuclear Waste and I wondered if Chamber members knew about my great uncle Jack. He lived to a ripe old age in the wilds of Romney Marsh on a small-holding. He had the one son, a clever lad, who helped him with the donkey work until he found himself in some trouble with the police.
