The Tax Payers Alliance has demanded that SEEDA be either "abolished or brought back under democratic control". Our own distinguished Chamber President, Bill Moses, has been widely quoted over his concerns that bodies such as SEEDA and Business Link "simply consume taxpayers' money, tick boxes and do very little." Last month, the BBC highlighted the spending on taxis of the SEEDA Chairman under the condemnatory headline on its website, "Seeda boss spent £50k on car bill"; even going so far as to reduce the final four letters of the organisation's acronym to the lower case.
