### 4. Issues for local business

**Unemployment** has fallen in the last twelve months. Kent has seen a 28.4% reduction in registered universal credit claimants, Canterbury has the lowest youth unemployment in Kent at 3%. Dover at 7.6% is ranked 8<sup>th</sup> out of 12 districts in Kent. Thanet has the highest youth unemployment in South East England at 10.6%.

**More Battery Electric Vehicles** (BEVs) were registered in Britain in 2021 than in the previous five years combined. The 190,727 new BEVs on our roads along with 114,554 plug-in hybrids (PHEVs), means that 18.5% of all new cars registered in Britain in 2021 can be plugged in. [SMMT, 6 Jan 2022]

**Aviation at Manston Airport** ceased on 5th May 2014. RiverOak Strategic Partners (RSP) acquired the site on 9th July 2019. On 16<sup>th</sup> November 2021, interested parties were invited to comment before 2359 hrs on 3<sup>rd</sup> December 2021 on the plans for the upgrade and reopening of Manston Airport. We now await a prompt and definitive decision from the UK government on the airport's future, as we have been doing for the last 7 years.

**Dover Skills Summit** took place on 17<sup>th</sup> December 2021 at the Dover Marina Hotel and Spa in the company of Natalie Elphicke MP and interested new Chamber members. Delegates discussed issues impacting on local business including the provision and availability of training courses to meet their current and future needs.
