I. Insurance

Following the warm reception given to our guidance notes, "Ten Sources of Advice on Employment Contracts", we are pleased to make available "Ten Sources of Advice on Insurance". 2. There's Money in Plant Pots

Last Wednesday, the University of Kent's Enterprise and Innovation Centre welcomed a party from Thanet & East Kent Chamber interested in exploring cooperation on research in the industrial application of porous ceramics. In layman's terms, a company that markets terracotta watering systems for domestic plant pots and hanging baskets, "water once and enjoy your holiday for 4 weeks" is looking for an industrial application of its technology. With the wholehearted support of the University, we are now looking at helping this company extend its markets and develop new products. Carole Barron, Director of Kent Enterprise at the University, and her colleague Dr Gary Robinson are keen to work with companies in Kent on research programmes, especially if there is a connection with bio-sciences. Carole predicts that the international biometrics market is poised for sustained growth, approaching revenues of US\$10 billion annually by 2020.

3. Get Your Money Back

You will not get all of it back, but you might get some. This refers to grants from public bodies which are financed with your taxes; both the grants and the public bodies. We are fortunate at the Thanet & East Kent Chamber to be able to call on the services of experts Brian Short and Jim Miller of South East Grants Advisory Service or SE-GAS as it is commonly known. If you need a new machine, want to employ more staff or undertake a new line of research, there may well be a government grant available to help you on your way. The beauty of working with Jim and Brian, the 'Ant & Dec' of the grants world, is that they do most of the work. At no cost to your company, SE-GAS will look at your requirements, advise you if a grant is available, how much you could claim and when you would be likely to receive your money. This Chamber holds regular Grants Workshops to assist you. A recent more liberal interpretation of the qualifying criteria for R&D grants means that many more Kent companies now qualify for funding. SMEs in Thanet are particularly fortunate as the whole of the area has Tier 2 status allowing for a greater level of support to companies. 4. Rates & Sandy Ezekiel

As mentioned in previous editions of Thanet & East Kent Insider, this Chamber is apolitical and is happy to work with democratically elected representatives at all levels of government. We are grateful to Cllr Sandy Ezekiel, Leader of Thanet District Council, for his support to our campaign to revoke the Rating (Empty Properties) Act 2007 and look forward to a diplomatic meeting in his office with Roger Gale MP (Con) and Dr Stephen Ladyman MP (Lab) on their return from holiday. It is in the commercial interest of all Chamber members to oppose this legislation which was conceived in happier times, but now threatens to destroy large parts of the industrial infrastructure of our coastal towns in Kent. Readers of the Thanet & East Kent Insider will receive regular updates on progress. The unqualified support of our professional association, the British Chambers of Commerce, brings with it the backing of 100,000 companies with 5m workers – a loud voice when we wish to use it and on this issue we do.
