#### I. Train to Lose

Sadly, all too often companies are reluctant to sponsor their staff on training courses. "Why should I invest in training Johnny Boy when as soon as he has completed his course, he will be off down the road to work for a competitor?" It's a fair point and no amount of remonstrating about how successful companies have successful training programmes and that is why they are successful is likely to make an impression if the key worker you spent one year training is now competing against you. There is another way. This Chamber is arranging to provide a Formal Training Contract (FTC) whereby a company can invest in training Johnny Boy knowing that if he leaves within an agreed period he must payback the cost of the training course. Readers of the Thanet & East Kent Insider will be kept informed as soon as the FTC is available. We see this initiative as making a key contribution to the skills base in East Kent.

Earlier this week, the Thanet & East Kent Charity Forum held its first meeting. Attended by representatives of the charity and voluntary sectors, delegates looked at best practice in fund-raising and discussed a range of initiatives to bring bottomline benefits to corporate sponsors. Where a train will run earlier for part of the journey, the earlier station calling times are shown in the timetable pages as the normal working times with a note to show that the train service will run slightly later in the period before the leaf fall timetables come into effect."
