#### I. In the News

The Thanet & East Kent Chamber's campaign against the new business rates on empty commercial property received a boost over the weekend. The Mail On Sunday quoted extensively from the words of one Chamber member, Mick German of MPG Properties, who is faced with a potential rates bill of £400.000 from properties that previously would have incurred no charges from government. Kent On Sunday also returned to the theme and for good measure added some words about our second campaign issue, pub closures. Our thanks to reporters, Neil Craven, Jeena Pudelek and Steve Wright. Our gratitude also extends to the industry bible, Property Week, which pays us the compliment of quoting extensively from our 25-page campaign pack and lists in detail, this Chamber's four reasons for repealing the Rating (Empty Properties) Act 2007. # 4. Thanet Works

At the Winter Gardens Margate this morning, we were treated to a visit from Paul Carter, Leader of Kent County Council, and committed supporter of the Thanet Works scheme. In brief, the Department for Work and Pensions in liaison with the Department for Communities and Local Government has awarded Thanet £4.057m to be spent between 2008 and 2011 on initiatives to promote employment among NEETs and deprived groups in Thanet. For a fuller discussion of NEETs, see the special edition of the Thanet & East Kent Insider of 16<sup>th</sup> October 2008. Chairman of Thanet Works is Cllr Jo Gideon who is keen to use the funds in innovative ways that will provide a sustainable solution to inherited social problems. Jo was joined on the platform by fellow Thanet Works Director, Colin Maclean, who brings with him considerable expertise and experience in the successful delivery of regeneration programmes. Philip Sturt of Job Centreplus also spoke in support of the scheme. This Chamber is represented on the main decision-making board and will promote the perspective of local companies to ensure that the business view is considered at every stage of development. If Thanet Works can reduce the number of people in Thanet on benefits by 7%, it will have more than paid for itself. This is a practical scheme being managed by practical people. Proof of this is that from 0930 hrs to 1400 hrs throughout all the deliberations involving numerous publicly-funded organisations not one person mentioned the word "vision". This is surely a first for Kent.

Ramsgate Town Partnership held a meeting at The Oak yesterday morning. Among the speakers was Terence Painter of Terence Painter Properties. He gave an update on the Royal Sands development of 107 luxury apartments, a hotel and retail outlets on Ramsgate beach. Despite being delayed by a crack in the cliff face, this project is back on track. The developers have already invested £2m in the infrastructure. Terry has received expressions of interest for 70% of the commercial units and 30% of the apartments. This is a local project that is committed to using local contractors for its construction.
