4. Facts About Thanet

At a meeting this morning to discuss the Local Development Framework for Thanet, Thanet District Council issued some key statistics. Of all the districts in Kent, Thanet has the highest percentage of households with children and no adult in employment. Thanet also heads the list of persons with a long term illness and residents in communal accommodation. In addition, Thanet has the highest proportion in Kent of adults with no qualifications. The government sets the target for the number of new homes to be built in Thanet. Currently, this is expected to be 7,500 in the period to 2026. The population is expected to grow by 700 people and households increase by 7,100. Most of the projected growth is in one person households. In the last few years, new homes have been built at the rate of 429 p.a.

5. Training and Education

The Leitch Report of December 2006 concluded that one in six UK school leavers is unable to read, write or add up properly. If the full potential for regeneration is to be reached in Thanet, we need the skills base to satisfy the demands of employers. This Chamber believes in supporting initiatives which promote a closer relationship between employers and state education. The Chamber has accepted an invitation to join the Thanet College Employment Engagement Steering Group.
