I. Over The Water

Yesterday, the Chamber visited our colleagues at the Calais Chamber of Commerce to discuss cooperation and cross-channel trading. The new Mayor of Calais, Natasha Bouchart, is keen to implement innovation. The slogan "Calais Change" is seen with increasing frequency around the town and port. This Chamber is anxious to take full advantage of the current favourable exchange rates so that our members can extend their markets overseas with reasonable margins. Our visit focused on practical measures to help our local companies. After the business of the day was concluded, it was suggested that an East Kent football team might wish to play a preseason friendly match against Calais. We will certainly investigate the possibility. We should be aware that although Calais Racing Union Football Club may field an amateur team of teachers, dock workers and office clerks, in the year 2000 it was good enough to reach the final of the Coupe De France (the French equivalent of the FA Cup) losing to Nantes in a tense and controversial final by just two goals to one.

2. A Kent First

Richard Durrant of Chamber member, Boys & Maughan Solicitors, had more reason than most to celebrate last Friday when he became the first Legal Executive in Kent to be made a partner. The changes brought about by the Legal Services Act 2007 allow the creation of Legal Disciplinary Partnerships (LDPs) which had previously been exclusive to solicitors. This Chamber is currently assisting one member who is poised to make a large investment in the area but had run into some difficulties with the planning department of Thanet District Council (TDC). After a preliminary investigation, this Chamber arranged for a meeting between the investor and the TDC planning department. This get together duly took place earlier this week. In the space of two hours, all the major problems were resolved and we are confident that construction of the inward investment project will begin within the next twelve months. Pre-application advice in some districts can be horrendously expensive. One department in London states its fees as: "£2,300 (excl VAT) for the first meeting and £800 for follow-up meetings." TDC makes no charge for pre-application planning advice. We welcome this support for the business community and look forward to working with other inward investors and TDC to resolve any planning difficulties before they become a problem.

4. Running For Cover

5. Give Us Your Money

Earlier today, this Chamber was invited by the Academy For Chief Executives to attend a Networking For Networth Conference near London. After marvelling at the great and good in attendance, see item 8 below, there was still some time left to receive some straightforward advice on issues such as how to raise capital for your business. Daniel Bastide, a partner at Thomas Eggar LLP of Crawley, listed some of the factors to consider when presenting a case to your local bank manager, finance house or venture capitalist. Scalability may not be the first issue that springs to mind, but your potential investor will be interested to know if your proposal can be easily expanded up or down the supply chain or sideways to include a greater range of products or services. Securing the ownership of the core intellectual property is also a key component in your bid as it reduces the opportunity for a competitor to cut and paste your ideas into their existing business. Your own track record as a manager or entrepreneur will also be in the minds of your financiers and it

is as well to have examples of your successes to hand and to be prepared to answer sometimes quite hostile questions as your potential backers seek to discover your true competence with their money.

8. The Man Who Freed Mandela

FW de Klerk is indeed the man who freed Nelson Mandela and earlier today he gave a superb speech on the nature of leadership and how to respond to the challenges that businesses are facing in the current harsh trading regime. His central thesis was that we should be prepared to change. He said that animals succeed by adapting to their environment but, uniquely among species, humans approach life differently. "Our personal success depends on our ability to change our environment to meet our needs". He accepts that "resistance to change is deeply ingrained in us" but noted that constant and continual change is essential at all levels of society and business. Many people pay lip service to change but fail to the revise the underlying problems; "They think of brilliant ways of doing the wrong thing better". He admitted that the government of South Africa had been wrong about apartheid. "For years we fooled ourselves that we could reform apartheid". He acknowledged that communications skills are at a premium and emphasized the importance of getting your timing right. "It is foolish to be vociferously right at the wrong time". When he first told Nelson Mandela that he was going to free him from prison on 11 February 1990, Mandela said, "No, that is too soon". FW De Klerk replied that the issue was not for discussion. He would decide as President, but conceded that Nelson Mandela could chose the time and place. Frederik Wilhelm de Klerk abolished apartheid in South Africa and introduced democracy. He will go down in history as a great president and decisive leader worthy of his Nobel Peace Prize and the many honours that have been awarded to him since he left active politics just over ten years ago. Over lunch later, we discussed the challenges for the business community of East Kent. The great man held firm to his recipe for success and said that we should never flinch from unpalatable facts but should "confront the in-born fear of radical change". He confided also that he was an enthusiastic golfer who, like his fellow South African, Gary Player, was finding that his drives from the tee were getting so short that he now felt he could hear the ball land.

9. Japan Again

Long-term planning is also much favoured in Tokyo and has been a revelation to some UK companies exporting to Japan and the Far East for the first time. Accusations that Japan buys up the raw materials of poorer countries,

adds value and sends them back at an enormous profit are not strictly justified in every case but perhaps underlie the anxiety behind this anecdote. A story frequently heard in Australia in the 1980s concerned a billionaire industrialist from Sydney who, having been diagnosed with a fatal disease, bought an insurance policy that specified that if he died within 5 years, his body would be literally put on ice ready to be resuscitated when the technology had progressed sufficiently to restore him to life. The sad but super rich Australian passed away officially in 1984. In the year 2025, he was revived and restored to health. Once he had full control of his faculties, he demanded to see the doctor. "What is the unemployment rate in Australia?" The doctor thought for a moment and replied: "We do not have any unemployed. All adults have a job if they want one." Scarcely able to believe such good news, our Australian friend continued: "What about production and quality standards and ..." The doctor stopped him there and added: "They are on par with the best in the world. Our streets are clean without a speck of litter and there is a 100% literacy rate among school leavers". Enormously impressed, our revived Australian industrialist asked: "What is the average weekly wage?" and he received the reply: "Oh, it is around 200,000 yen per week." Nuff said.
