I. Blowing In The Wind

There is £800m blowing in the wind from Sweden and we would like as much of it as possible to be spent in East Kent.

2. Signs of Recovery

We are grateful to Chamber member Adecco, a sponsor of the Thanet & East Kent Insider, for bringing to our attention a report from the National Institute of Economic and Social Research (NIESR) which claims that the economy grew by 0.1% in May 2009 and by 0.2% in April, after contracting by 0.5% in March. Such optimistic news has stimulated the interest of HR companies and recruitment consultants in East Kent. Other data from the Office for National Statistics showed industrial production rose by 0.4% in March and April giving optimists the hope that the economy may have reached its nadir. The Recruitment & Employment Confederation publishes its own report in liaison with KPMG. In its summary of performance for May 2009, it noted that some sectors of the economy may have bottomed out but concluded that "it remains difficult to build real optimism of an incipient recovery because most of the world remains mired in the depths of recession." Readers of this weekly bulletin will have their own experience of how green are their shoots of recovery but some good news is welcome and we look forward to the day when unemployment figures start reflecting an upturn. 4. Four More Years

Further to item 2 above, NIESR is also well-known for its detailed research on other aspects of our economy. A recent paper entitled Macroeconomic Implications of Pension Reform includes the opaque statement that $dlnCt = \lambda(lnCt-1 - b0 - lnPlt-1) + b1 dlnRPDlt+b2 dlnNWt+b3 dlnHWt.$ If this equation has not appeared on your screen in a legible form, count your blessings because a Nobel Prize in mathematics would not guarantee an understanding. Such highly technical reports are attractive to most of us only when we get to the executive summary or the conclusion. It takes three authors to produce text like that. Ray Barrell, lan Hurst and Simon Kirby finally come into our sphere of comprehension after 10 pages when they declare that we are all living longer and the official retirement age will have to rise by four years if the nation is to support its aging population. If you are now under 45 years old and working in the private sector, you may find that you will be expected to work until you are 69 years old. Sales of cardigans and slippers may fall and purchases of briefcases and suits could increase. Over the next decade, any company servicing the needs of the active, elderly working population may be well-placed to benefit from the so-called demographic time-bomb resulting from our increasingly long lives.

5. News from Other Chambers

Dover District Chamber of Commerce informs us with great pride that a Big Screen is being erected this week in the Market Square, Dover. Local ratepayers are comforted in the knowledge that the screen is a gift from the organizers of the 2012 London Olympics. A key element in Dover District Council's regeneration strategy, the screen will also be used to showcase locally produced short films, Dover events and live opera and ballet from Covent Garden. It will be up and running in time for the Blériot festival on 25th and 26th July which will celebrate the 100th anniversary of Louis Blériot's cross-channel flight. The Channel Chamber reports that local businesses overwhelmingly support the expansion of Lydd Airport. In a recent Chamber survey of local companies, over 90% of respondents considered that airport expansion would be good for business. Airport Managing Director, Cliff Spink, is quoted as saying, "If we are allowed to develop operations I really believe that Lydd can act as a catalyst for economic regeneration in the region, creating jobs and bringing hope to local communities blighted by soaring unemployment." Well said, Sir.

6. Do You Know Where You Are Going?

The University of Kent held a Leadership for Growth and Performance workshop for SMEs yesterday which summarized the research conducted by Dr Mark Gilman and his team at the Kent Business School. One of the key facts presented from a survey of over 500 Small and Medium Enterprises (SMEs) in Kent and Medway is that only 42% have a business plan and of these only a quarter develop their plan during the course of a year. The old army adage that if you fail to plan, you plan to fail applies to around 9 out of 10 SMEs. Such are the pressures these days that smaller companies are increasingly relying on 'gut feeling' rather than benchmarking or detailed research. Know Your Destination is of course as important as Know Your Customer and Know Your Competitor. Dr Gilman has accepted an invitation to speak at a business breakfast before the end of the year so that Chamber members can benefit from his thoroughly researched insights into SMEs in the county. "Where there's muck, there's money" is a phrase that has lost popularity in recent years as our manufacturing industries have declined and the service sector has grown. However, the United Arab Emirates is particularly keen to promote green energy and to convert its own waste into electricity. Ajman, the smallest of the seven emirates that constitute the UAE, is looking for a UK company to build an Energy From Waste facility which can generate 10 - 12 MW from an Independent Power Plant. Ajman produces around 500 tons of waste per day and the successful bidder will have to liaise with the municipal bodies that serve the population of around 600,000.
