#### I. Police Plans & Priorities

Kent Police Authority has just published its plan for policing Kent for the next three years. In a comprehensive document of 58 pages, we learn of the strategy outlined for "building public confidence, effectively tackling crime and anti-social behaviour, protecting the public and making the best use of our resources". The Kent Police Authority Chair, Ann Barnes, and the Chief Constable, Michael Fuller, note in a foreword to the document that the policing of the Climate Camp at Kingsnorth power Station on the Hoo Peninsular in August last year presented a particular challenge as one of the biggest policing operations ever undertaken by the force. They take understandable satisfaction in reflecting that normal levels of policing were maintained throughout the county and the demonstration ended peacefully. Anyone unfamiliar with the terminology of law enforcement will be relieved to know that a handy glossary appears at the end of the document. This reveals that to police insiders LSC refers to the Legal Services Commission and not the Learning and Skills Council. Similarly, IOM does not relate to the Isle of Man but to Integrated Offender Management. Anyone from the Lingfield Sowing Circle or the Institute Of Masochists might object, but for most of us the glossary is a welcome addition. The Panel has found that of those who do turn to others for advice on improving their finances, one third went to their mortgage provider, while one in four asked a Citizens Advice Bureau. #### 6. How Are We Doing?

The British Chambers of Commerce publishes a Quarterly Economic Survey (QES), the largest and most authoritative independent report from the private sector which covers over 5,000 businesses in every region of the UK. It is published in advance of official figures and is closely monitored by the Treasury and the Bank of England. The feedback for the second quarter

of this year produced some mixed results. There was improvement in most critical national balances, but by historical standards the levels are decidedly weak. Second quarter balances in manufacturing for home sales and orders showed an improvement of 18 points but remain down 37% for the year. The domestic service sector increased by 7 points for the quarter but is still 16% below last year. Similarly, home orders are 24% below this time last year but show a rise of 5 points from the previous quarter. Export performance, investment and cash flow are all significantly below last year's positions. Employment in manufacturing is at its lowest level since QES began at the beginning of 1989. Only 20% of manufacturers are working at full capacity, a position that is unchanged from the first three months of the year. Quarterly manufacturing cash flow balances remain unchanged at an historical low of -32%. Pressure to raise prices is still weak. Born optimists looking for any possible sign of a recovery will take heart from a general view that the worst may be behind us. Although 2009 Q2 confidence ratings are low by comparison with the past, they are now positive. Manufacturers report a +2% expectation that turnover will improve, a rise of 40 points, and the service sector is also looking forward to a 19 point rise in turnover, giving a year-on-year confidence rating of +7%. The BCC concludes that "The Q2 results confirm that the pace of decline is clearly easing. The worst phase of the recession is over, but serious downward pressures persist across all sectors and regions". It continues that "Talk of recovery is premature" and recommends the adoption by government of "a credible medium-term strategy for improving our public finances".

## 7. Can You Credit It?

The Thanet & East Kent Insider often reports on the importance of credit control, enticing the reader with headlines such as "Get The Money In" (19<sup>th</sup> March 2009) or "Managing Cash Flow and Credit" (20 November 2008). Regular readers will know that the most common cause of business failure for new companies is poor cash flow. In other words, you pay your suppliers but your customers do not pay you. The Institute of Credit Management is the professional body that oversees the training of credit managers and is interested in your experience of managing credit.
