I. Business Rates and Breakfast

On Tuesday 22nd September 2009, this Chamber will be hosting a business breakfast at Salmestone Grange, Margate. The main speaker will be a senior official at the government's Valuation Office Agency. He will explain the current policy on setting business rates for shops, offices, factories and commercial premises in Thanet and East Kent. In addition, he will outline the plans for a revaluation exercise due to take place in the next three months which will fix standing charges for the period from April 2010. This breakfast meeting will be of interest to any company paying business rates. In addition, after the meeting, Chamber members will be able to discuss their own charges direct with one of the key decision-makers. The government's revaluation exercise will be based on land values in April 2008, i.e. before the peak of the recession and so it is important that the VOA is aware of particular circumstances in certain areas. 2. Margate High Street

At a meeting yesterday hosted by the Margate Renewal Partnership, developers gathered to give their views on how the retail area with the highest percentage of empty shops in Britain can be improved; Margate High Street. Discussions focused on parking, relocating a street market, usage of the former Marks & Spencer building, street crime and footfall. The optimism for the future was based on a series of initiatives that is already bearing fruit. A drop in reported crime and new grant aid to be awarded to improve the external appearance of shops should help matters. The plans now at an advanced stage to redevelop the Arlington House site to include a Tesco outlet were featured in a press release of yesterday by the Thanet District Council Deputy Leader, Cllr Roger Latchford. He declared that, "We want to ensure that Arlington House residents, who are entitled to a say about how the appearance and quality of their homes, are consulted about how their surroundings are to be improved." We understand that the development might include a 50,000 sq ft area for a medium-size Tesco supermarket. Speaking exclusively to the Thanet & East Kent Insider later, Derek Harding of Margate Renewal Partnership said, "Margate is on the verge of some very welcome and exciting times. The town has been in decline for many years but we believe it is starting to turn the corner". David Kinnear of Margate Town Parnership echoed these words in another exclusive to the Insider. "Because of the struggles Margate has faced in the past, inward investors now have unique opportunities for developing projects in the town".

3. Turner Contemporary Gallery

Visitors to the site of the new £17.4m Turner Contemporary Gallery on Margate seafront can at last see the building appearing above the surface. Construction work began on 19 December 2008 and is expected to be completed by the end of 2010. As it is expected to host some extremely valuable paintings, the building will undergo extensive trails before opening formally around May 2011.

4. Average Wages

Figures released by the Office for National Statistics reveal that the median gross weekly pay for an employee at a workplace in Thanet is £384.40. Interestingly enough, the same methodology reveals that the median gross pay for a resident of Thanet is £42.40 per week more at £428.80. From this, we deduce that there is an incentive for companies to locate their workplace in Thanet in terms of reduced salary costs. On the other hand, a resident of Thanet is tempted to work outside the district in order to receive a higher average wage. [NOMIS Dec 2008].

5. Attracting Skilled Workers

An oft-quoted difficulty faced by some firms on the East Kent coast is attracting skilled workers. A visit to the government's databank reveals the extent of the problem. Thanet adult residents with a qualification at NVQ3 and above, the equivalent or 2 or more Alevels, number 34.8%, just over one in three. In the South East as a whole, half the population is formally qualified to this level, to be precise 50.8%. [NOMIS Dec 2008]. This may at first appear to be a significant barrier to inward investment. In fact, local companies are fortunate that the private sector has supplied some first class employment agencies that can provide the skilled talents and qualities required.
