2. Hollywood In Thanet

Not yet perhaps, but MEDB Films with the support of Kent County Council is paving the way for a vibrant film industry in East Kent. Paul McGann, Bob Hoskins and Ramsgate's own Brenda Blethyn and have all starred in this company's feature film output. Another star in MEDB's address book is Rula Lenska, a former student of Ursuline College at Westgate-on-Sea who is entitled to call herself Countess Roza-Marie Leopoldyna Lubienska if she so chooses. Based at Chamber member Royal Harbour hotel, MEDB Films has pioneered the UK use of DOGME 95 techniques which require a faithful portrayal of the real world with minimal post-production. Another successful entrepreneur in the arts is Roger Dudding who directed the extraordinarily successful social programme of last month's Ramsgate Yacht Week. The DVD produced by his film company gives a clear overview of the successful evenings at the Royal Harbour culminating in a performance by the Counterfeit Stones who, according to witnesses, performed better than the Rolling Stones ever did in their prime and gave satisfaction to everyone in the audience. The imminent refurbishment of the Old Customs House, the promise of high quality executive apartments at the Royal Sands development and the continuing attraction of the surrounding blue flag beaches suggest that Ramsgate is well positioned to take full advantage of the launch of the High Speed I fast rail link to London St Pancras which is due to launch its full programme of services on 13th December 2009. Southeastern Railway has already estimated that the HS I link to Ashford has boosted the average house price by £12,000. Will we see a similar rise in Ramsgate from next December? This Chamber is monitoring the market and will keep readers fully informed.

3. Branding

How does your company manage the branding of its products and services? Is your company name a byword for integrity and quality? Is branding so important anyway? Jez Frampton, Global Chief Executive of Interbrand, clearly thinks so. In the preface to Best Global Brands 2009, he writes, "In times of rampant change, brands remain a powerful source of continuity and trust." This year's list is headed again by Coca Cola followed by IBM, Microsoft, GE and Nokia. Google has risen from 10th to 7th. Toyota has dropped 2 places to 8th. The top fifty brands are heavily dominated by US companies. HSBC is the only British company to feature and appears in 32nd position. The correct branding is an important element in your company's success. As Jez Frampton puts it, "Tough markets demand differentiation and value-add like never before. If your brand isn't clear and compelling, you will soon become lost in a sea of price-based competition". Some Chamber members have reprofiled their companies with success. The Consilium Group under Justin Baker now trades as Logo ID and is winning business from new customers.

6. Pre-Pension People Plea

Thanet Senior Citizens Forum has approached the Chamber to ask if we can help with a request from programme maker Wall to Wall Television which is making a film for Channel 4. 7. Rating (Empty Properties) Act 2007

This Chamber's long-standing campaign against the empty rates legislation, introduced with much controversy in April last year, has received a welcome boost from the Chief Executive of the UK Warehouse Association, Roger Williams, who is quoted as saying, "The Government's move to scrap rate relief on empty industrial property has led many landlords to demolish perfectly sound warehouse property as a way of avoiding paying the substantial amounts of tax that unoccupied facilities now incur. Indeed, a recent report by property consultants Lambert Smith Hampton, found that owners of properties tended to wait for 12 to 18 months once a property had become vacant before making the decision to demolish it, which indicates that the speed of demolition of warehouse buildings is likely to increase in the near future." This is precisely what this Chamber predicted nearly two years ago. The continuing demolition of warehouses, factories, pubs and offices deprives established businesses and start-ups of the budget accommodation that is sorely needed by the East Kent Business community.

8. Business Rates

Next Tuesday's Business breakfast, see item I of last week's Insider, will feature an interactive session with a senior official of the Valuation Office Agency (VOA). The civil administration is listening to us and we welcome it. This Chamber has learned that the Government is looking to raise in excess of £22 billion annually from almost I.8 million properties. This is approximately five percent of total tax receipts, confirming Britain's position as the most heavily taxed property economy in Europe. We have a once only opportunity next Tuesday to plead the case for Chamber members in the Thanet & East Kent business community. Once the business rates have been fixed, it will be difficult to make any downward adjustments in the five years from April 2010.

9. Margate Harbour Arm

The issue of branding, see item 3 above, may have been in the mind of Jean Berwick when she named her delightful café on Margate Harbour Arm, Be Beached.
