#### I. Pensions

Discussing pension arrangements is about as attractive to most people as eating cold custard with Brussels sprouts, but the government's Department for Work and Pensions is understandably keen to ensure that companies and employees are not taken by surprise by new arrangements. At a seminar at Westminster earlier this week, the DWP explained that in the year 1901, there were 10 people working for each UK pensioner. In 2005, this was reduced to a ratio of five to one. By 2050, it is estimated to fall to two workers for each pensioner. When the uncrowned King Edward VIII visited the depressed mining areas of Wales in 1936, he declared that "Something must be done". He left office not long afterwards. The current Secretary of State for Work & Pensions, the Right Honorable Yvette Cooper MP, must be hoping that she does not suffer the same fate because something must be done about pension provision if the UK is to offer a dignified retirement to its senior citizens and retired workers. Current plans propose that from 2012 employers will be required to enroll 'all eligible jobholders' into a qualifying workplace pensions scheme and to make contributions to it.

## 2. How Much Will The New Scheme Cost Me?

At current pay levels, employers will eventually be obliged to contribute 3% of salary for those workers earning between  $\pounds$ 5,035 and  $\pounds$ 33,540 a year. The worker's own contribution and a 1% tax relief will bring the overall payment to a minimum of 8% of salary. Anyone earning less than  $\pounds$ 5,035 per year may opt in to their employer's pension scheme, but the company is not obliged to make a contribution in such cases. These thresholds are liable to rise before 2012. Companies with a scheme that meets the required quality standard may continue with their current arrangements. The charges are likely to be phased in with large companies pioneering the arrangements from October 2012. Full details should be available in 2010. For an example of how these changes are likely to impact on a worker earning  $\pounds$ 25 a week,  $\pounds$ 17,000 a year,  $\pounds$ 37,000 a year and  $\pounds$ 45,000 a year, email admin@tekc.co.uk with the subject line 'New pension examples''. The government envisages heavy fines for a 'non-compliant employer' ranging from  $\pounds$ 50 per day for a company with four workers or fewer to  $\pounds$ 10,000 per day for large companies. The Pension Regulator is also expected to be given the powers to fine pension scheme managers, trustees, accountants and administrators an escalating penalty of  $\pounds$ 200 per day. Perhaps Brussels sprouts and custard is not so bad after all.

## 3. Oh Dear. Who Can Help Me With Pension Advice?

The good news is that the changes listed above are not due to take place for two years. The obligations on the employer will increase considerably. Companies should be aware of the words of David Norgrove, the Chairman of the Pension Regulator, who wrote in his annual report last June, "Our new statutory role is to maximise employer compliance with the new duties". ## 6. Thanet Off-Shore Windfarm

Our friends at Thanet Offshore Windfarm have contacted the Chamber with news of an Open Day at the Royal Temple Yacht Club. Regular readers of the Thanet & East Kent Insider will recall that the edition of 25<sup>th</sup> June 2009 gave full details of this £800m project which is expected to be completed by October 2010. The one hundred wind turbines currently being built off the Thanet coast are expected to produce sufficient electricity to power 240,000 households. ## 7. More Money Available

Roger Gale, MP for North Thanet, has contacted the Chamber with news of a scheme to facilitate lending to small businesses by the Royal Bank of Scotland and NatWest. Stephen Hester, appointed by the government last year to deal with the serious problems at RBS, has written to Roger with details of an initiative that provides a Business Hotline to existing and potential customers with the promise of a named case worker to be appointed with 48 hours and a decision on finance within a month. Since his arrival last November, Stephen Hester has done much to end the culture of excess at RBS including cancelling an order for a £31 million private jet for its senior executives.

Education Walsall was recently rated by Ofsted as the most improved Local Education Authority in the country ever. With highly developed operations in Aviation, Health, Housing, Security, Science and Transport, there is obviously more to Serco than emptying your bins, as we are about to find out in East Kent.

## 9. Thank You Rob

The last minute cancellation of the relocation of Thanet College to a new site at Westwood Cross was greeted with acute disappointment by all those with the best interests of Thanet's business community at heart. Politicians of all parties campaigned to support the £82.2m project. If the severe budget cuts at the Learning & Skills Council meant that the new measures introduced at the LSC now hit the target but miss the point, none of that can be attributed to the hard-working staff at Thanet College nor to the outgoing Relocation Director, Rob Thrower, who provided an inspirational focus to the project and will be sorely missed by all those who worked with him.
