In contrast to a previous owner, IAEL is backed by a parent company, Infratil Ltd, which is based in New Zealand and controls or influences assets worth £1.7 billion. This gives IAEL a stability and established strength which have enabled the company to invest over £30 million in the past four years. IAEL states that it is committed to 'seeking out further airport investment opportunities in the UK and throughout Europe'. The Director General of the British Chambers of Commerce, David Frost, has forecast that the economy will grow by 1% next year rising to 2.3% in 2011.
