I. Finance & Grants

The Chamber Finance & Grants Workshop took place earlier today at the Chamber offices. To a full house, Brian Short of South East Grant Advisory Service, Se-gaS (that is the official acronym, honest guy), and David Milham of ASC Finance outlined the sources of public and private funding available to companies in Thanet and in Kent. A full report will follow for members unable to attend the event. A key point about eligibility for grants from SEEDA is that the project must not have started. In other words, if you are looking to purchase new machinery or take on the lease of new offices, it is too late for a grant if you have already paid a deposit. If you consider that you have a case for a grant, speak to Brian first. If the grant application is for a sum below £1m, the services of Se-gaS are free for Chamber members. To date, Brian has successfully nurtured 333 grants totaling £26.4m. David Milham was able to reassure the room that the banks are still interested in financing SMEs, although typical loans are now likely to be at 1.5% to 3% above the base rate rather than the 1% - 2% that was the case at the start of the year. Loans on commercial property have also suffered from the debilitating effect of the sub prime crisis. The prospective owner of an office block who might have qualified for a loan of 85% of the purchase price must probably be content now with only 75%. He also summarized the Small Firms Loans Guarantee Scheme which is available to small companies that may not qualify for a bank loan. 5. Reduce the costs of credit card processing?

The increased benefits that we can now offer following the partnership agreement with the Channel Chamber mean that Thanet & East Kent Chamber is now offering you many more services designed to reduce your costs and increase your profits.
