2. Business Rate Relief Form

We are grateful to Mrs Harvey, Operations Manager at Thanet District Council Revenues and Benefits Service, for supplying the Thanet & East Kent Chamber with the latest claim form for Small Business Rate Relief. The Secretary of State has introduced new regulations covering entitlement for the period I April 2007 to 31 March 2010. It is in the nature of such legislation that it includes strange words framed and used by a select group of trained civil service linguists who do not get out very often. We are grateful to Mrs Harvey for supplying a translation. "hereditament" refers to a property on the Non-Domestic Rating List which does not include any residential property and is separately banded for Council Tax purposes. The main conditions for claiming rate relief remain the same and consist of three main issues. Firstly, relief can only be claimed on one hereditament. Secondly, additional hereditaments with rateable values below £2,200 are ignored. Finally, the total of all hereditaments must be less than £15,000. You can also take immense comfort in the knowledge that you are now probably the only person in your family who knows what hereditament means.

6. Scrappage Scheme Update

Readers of the Thanet & East Kent Insider will probably have heard that the Government's Scrappage Scheme has been extended until the end of March 2010. Although no new money has been allocated, the scheme has yet to reach its limit of 400,000 vehicles. It is likely that that VAT revenue to the Treasury from scrappage has exceeded the cost to the government giving the Chancellor every incentive to extend the arrangements. For anyone unfamiliar with the details, we understand the main points to be as follows. The vehicle you submit to the Scrappage Scheme must be a a car or small van not exceeding 3.5 tonnes, registered in United Kingdom on or before 29 Feb 2000 for cars or 28 Feb 2002 for vans and registered with the Driver and Vehicle Licensing Agency (DVLA) or Driver and Vehicle Agency in Northern Ireland (DVA) in your name. The vehicle must have been registered to you without a break for 12 calendar months before the order date of the new vehicle. There must be a UK address on the registration certificate and a valid current MOT test certificate before the date of order for the new vehicle. The tax disc must be up to date and the vehicle insured. The new vehicle you wish to buy must be a car or small van not exceeding 3.5 tonnes, first registered for the first time in the UK on or after the 18 May 2009, declared new at first registration in the UK without any previous keepers and must be of UK specification. The new vehicle must also be registered to the same keeper as the scrapped vehicle submitted.
